1. According to the stakeholder's response and the recommendation of the experts on the present course and syllabus etc. may be re designed. So, the recommendations are forwarded to the concerned University vide College despatch No. BLBC/IQAC/2017/441 Dated 22/8/2017 for take necessary action.
2. The librarian of the college is advised to do the needful for procuring required books and journals through Library Committee meeting and to have NLIST and DELNET membership. Accordingly the college is registered as NLIST member on 21/4/2017 and DELNET on 14/3/2017 (Member ID: IM- 6791)
3. Some career counselling programmes were conducted during the session (organised on 28/2/2017 and 29/6/2017)
4. An amount of Rs. 50,000/- is utilised for IT infrastructure especially for high-speed Internet connectivity.
5. Remedial classes are arranged regularly and unit tests and Examinations are conducted in the stipulated time covering all units of the syllabus.
